Chief Executive Officer and General Manager of Rete Ferroviaria Italiana since December 2020

After graduating with honours in Economics and Commerce from the University of Rome “La Sapienza”, during her career she held managerial positions of increasing importance within the FS Italiane Group.

She began her career in 1989 at IZI S.r.l., a consulting company, conducting investment appraisals and monitoring.

In 1995, she joined TAV S.p.A., initially as HS Project Planning Manager for the TO-MI-NA Axis and MI-Venice Cross-Section, and later as Structuring and Management Director for the budget, control and authorisation process of railway infrastructure investment funds.

At the beginning of 2001, she moved to Ferrovie dello Stato S.p.A. with the position of Budget and Investment Control Manager, before joining the newly-formed company Rete Ferroviaria Italiana controlled by FS in October, as Investment Planning and Control Manager.

From 2008 to December 2020, she held the position of RFI SpA's Administration, Finance and Control Director, a position she held *ad interim* until January 2021.

From 2014 to 2017, she was a member of the Board of Directors of FS Sistemi Urbani Srl.

From 2015 to 2022, she served as President of the Board of Directors of Grandi Stazioni Rail SpA, a wholly-owned subsidiary of Rete Ferroviaria Italiana SpA, in charge of upgrading, enhancing and managing Italy's fourteen main railway stations.

From 2016 to 2022, she was Chairman of the Board of Directors of Blufferies Srl, a company wholly owned by RFI with the corporate purpose of ferrying rubber-tyred vehicles across the Strait of Messina

From 2017 to 2020, she was President of the Board of Directors of Ferservizi SpA, an FS Group company.

In the past, she was also a member of the Supervisory Board of the Brenner Base Tunnel - Brenner Basistunnel BBT SE, a member of the Board of Directors of the Tunnel Ferroviario del Brennero - Società di Partecipazioni S.p.A., ANAS SpA, and LTF (Lyon Turin Ferroviarie).
